APPLICATION

Forms must be clean, dry and free from cement residue, rust, scale, etc. Brush or spray on a thin coating avoiding excessive build-up, runs or puddles as this may surface retard the concrete. Initially apply before the first casting and thereafter re-apply as required.

Note: New timber and plywood may completely absorb the first coat requiring a second application.

LIMITATIONS

- not for lift or tilt-up construction
- not recommended for use in auto claves

COVERAGE

PACKAGING

208L (55 U.S. gal) drums - 194 kg (428 lbs.)/drum 18.9L (5 U.S. gal) pails - 18 kg (40 lbs.)/pail

CLEAN UP

Clean spray equipment, brushes, etc with mineral spirits.

STORAGE

Store under heated warehouse conditions where possible. Avoid all contamination with water (for exterior storage store on side only). Sub-zero storage (0°C/32°F) not recommended.

SHELF LIFE

Two years from the date of manufacture in original, containers providing product has not been contaminated with water.
